My Right To Respect

For many years, Rizwan* and his older brother experienced discrimination due to their physical disabilities. Rizwan's family were excluded and looked down upon by others in their community in central Bangladesh. 'People used to mock us, and such behaviour broke our spirit. We often felt lonely, isolated, and helpless . . . burdens to society.' As a result, the family faced significant financial hardship and couldn't afford school fees or medical treatment. Rizwan says, 'no one would give my brother a job and I was excluded by my classmates from games and sports, as they believed I was too weak to participate.'



Then, Rizwan joined a Child Club run by Baptist World Aid's Christian Partner and learnt about his right to attend school and experience fair and equal treatment. The program also provided Rizwan with a mobility aid called a Boston brace, to help him walk comfortably. 'Now, I can attend school, join games, and even help at home. It has given me strength and independence'. However, Rizwan says that the biggest change in his life is not what he received but his belief in himself!

Rizwan is now nine years-old and dreams of a world where those with special needs are treated the same as other children. And through our Partner's awareness activities, Rizwan's community is on the way.

'I don't feel invisible anymore . . . I can confidently say that I feel safe, accepted, and I know my rights. I can play with other children and express myself freely!'

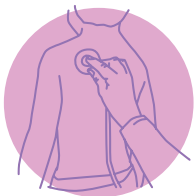
Did you know? The United Nations' 'Convention on the Rights of the Child' details what every child is entitled to, including:



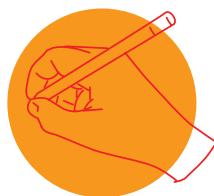
The right to be treated fairly



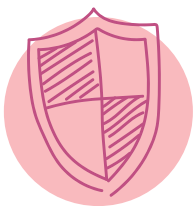
The right to have a say about decisions affecting them
