Thanks For Being A Friend

AND SUPPORTING PEOPLE LIKE JAGMATI

Well done on helping your friends get involved in the fight against the injustice of poverty.

Did you know that friendship is also helping to solve the underlying causes of poverty? Here's a story you might like to share as part of your fundraising event.

Jagmati grew up in Nepal in a Dalit family – the so-called 'untouchable' people. She never went to school, and at just 15, entered into an arranged marriage with an abusive, alcoholic man. Poverty seemed inescapable, and she spent decades feeling isolated and defeated.

But when Jagmati was in her 40s, she joined our local Christian Partner's Self Help

Group, and things started to change. Self Help Groups, used by our Partners around the world, bring local women together so they can access training and other support to escape poverty. Jagmati learned the skills needed to farm pigs and develop a reliable income, but more than that – she gained confidence from having friends who loved and supported her.

Together with her friends, Jagmati formed a plan, and they approached her husband as a group about his harmful behaviour. Remarkably, he recognised his need to change.

Now he's given up alcohol and works side-by-side with Jagmati on their blossoming farm.



Your efforts help keep programs like these running, so more people like Jagmati can have the support they need to thrive.




Make The Most Of Your Fundraising Webpage!



CHOOSE PHOTOS

Upload a profile pic and a background image that makes sense for your fundraiser. It could be a birthday scene, a fun run finish line, or a photo of the country where you'll be directing raised funds (stock images can be found at www.unsplash.com).



TELL US ABOUT YOURSELF

Write something about yourself or your team, and why people should donate. Short and sweet is best!



SET YOUR \$ GOAL

Be ambitious, and don't be afraid to change your goal later if it looks like you'll reach it early — what a great problem to have!



ALWAYS SAY THANK YOU!

Don't forget to thank everyone who gives. Let them know how much you raised, and how their money will be used to fight poverty — be as specific as possible.



SHARE THE MESSAGE

Jump on the socials, or email friends and family and invite them to share your passion to end poverty. It's okay to be direct in this context, so be polite and to the point when you ask them to donate. You can send people straight to your fundraising page by copy and pasting the URL. And don't forget to make a donation yourself — people are more likely to give when they see you've invested too.



Practical Stuff To Consider

Insurance—unfortunately, Baptist World Aid's insurance will not cover your fundraising activity, so you'll need to check whether you need public liability or other kinds of insurance. If you're using a venue, ask whether their insurance covers your planned event.

Venue Hire—this can be expensive. But many churches are happy for you to use their venue for free or a low fee when they know it's for a good cause. Ask around!

Tax Receipts—Baptist World Aid Australia has tax-deductibility status for donations of \$2 or more. Individuals who support your fundraising activity are entitled to receive a tax-deductible receipt. Please note that tax-deductible receipts cannot be issued for donations made to a raffle, auction, ticket, or to someone who provides a good or service.

Phone
