Message from CEO

It is with a deep sense of joy and gratitude that I present the 2022 Annual Report of Transform Aid International, having become CEO during this time.* To lead this organisation and the significant and transforming work that we engage in is a great honour. I know I am not alone in feeling this way—our work is only possible because our staff, volunteers, International Partners, partner churches and supporters similarly understand both the privilege and responsibility we have in joining God in his work in the world, work that results in a better world for all.

Who would have thought that more than two years on, we would still be needing to factor the challenges of a global pandemic into everything we do? But this last year has continued to test our commitment and resilience.

Alongside the continuing cycles of new variants of the COVID virus, our world has also experienced significant climate distress playing out as severe drought across Africa and the Middle East, while Australia has seen catastrophic flooding. Conflict in Afghanistan, Myanmar and Ukraine has added another layer of devastation. COVID, climate crises and conflict

deeply affect the communities where we work. This, alongside our mandate to serve the poorest and most vulnerable, has made our work through 68 projects in 24 countries and alongside 37 Christian Partners more important than arguably any time in our 63-year history.

Thankfully, our Partners and supporters are committed and resilient too, and together we have exceeded our performance targets. The numbers are important because they represent our ability to extend the biblical principles of justice and equality to more people who would not otherwise experience these. We are so grateful that even though the economic climate here at home is uncertain. the Australian Baptist family and our other faithful supporters have continued to provide sacrificially to allow us to impact the lives of more than 883,907 people, including 311,402 children.

We do see a world without poverty and one where all people enjoy the fullness of life God intends. We do believe in 'your kingdom come, on earth as it is in heaven'. This is what we are called to and what will continue to guide, shape and inspire our work in the years to come.

I'm especially grateful to the staff, volunteers and faithful supporters who ensured a Matching Grant result that surpassed that of past years, ensuring the good work we're doing will continue with strong support.

We also gratefully acknowledge that in FY2022, Transform Aid International was supported by the Australian Government through the Australian NGO Cooperation Program (ANCP). We're thankful as always to have the trust and support of the Australian Government.

Although we have worked hard to manage projects and International Partner relationships remotely, we're so thankful we can return to a sustainable and appropriate level of international travel. There's nothing quite like face-to-face interactions with our local Christian Partners.

As God prepared in advance for us to do these good works, to care for those on the margins and to respond to an emerging food crisis around the world, we acknowledge our role in God's restoration story. Advocacy for Justice

'Let justice roll down like waters, and righteousness like an everflowing stream.'

AMOS 5:24

In a year of global instability and multiple crises, our advocacy sought to add the voices of the Baptist movement to Amos' cry, 'Let justice roll down like waters, and righteousness like an everflowing stream' (Amos 5:24).

In August 2021, as Kabul fell, we mobilised advocacy efforts together with Micah Australia and other Christian organisations. The Christians United for Afghanistan campaign called for generous humanitarian aid response and a boost in Australia's refugee numbers from Afghanistan. Baptist leaders wrote to and met with the former Immigration Minister and Treasurer, and over 1,000 signed the call to action. After a slow initial response, the campaign achieved a bipartisan commitment to bring 16,500 additional Afghan refugees to Australia over the next four years.

Our advocacy for aid continued through the *End COVID for All* campaign. Partly as a result of this advocacy, the 2022 Federal budget saw a small increase in aid funding in the form of COVID response packages in the Pacific. It also contributed to announcements by the new Government that will increase the aid budget by over \$1 billion in the Pacific and Southeast Asia.

Our work to address labour rights and environmental sustainability in global supply chains remained a priority in FY2022, including the first *Ethical Consumer Report* launched in July, and the eighth *Ethical Fashion Report* in October. Both achieved significant coverage in national, religious and fashion

media, and strengthened our influence with more than 100 companies in the industry.

As part of a new collaboration with eight Australian universities and civil society organisations, we reviewed the impact of the first year of Modern Slavery Act in four critical industries. The *Paper Promises* report was launched in February and cited in the new Government's pre-election modern slavery policy, as well as in the issues paper for the Attorney-General Department's official review of the Act.

During this year, we also launched the first ever *Justice 2021 Report* in collaboration with other agencies across the Baptist movement. The report focuses on eight major issues of justice, from domestic concerns where others lead, to the global issues where Transform Aid International provides leadership climate and environmental crises. global poverty and humanitarian crises, and modern slavery. The report provides the policy foundation for advocacy across Baptist churches including through Converge, a national Baptist lobbying initiative held online in 2021 due to COVID lockdowns.

This deepening collaboration through the Baptist Advocacy Roundtable is also reflected in the launch of the refreshed *Catalyst Network*. Building on the faithful advocacy of Baptists over many years, Catalyst is now increasingly focused on youth and young adults, and seeks to equip and inspire advocacy on global, national and local issues.

National Engagement

A focus on our organisation's mission and vision saw us deliver substantial changes to our brand, fundraising and marketing approach in FY2022.

Firstly, we launched a new visual identity for Baptist World Aid Australia (a subsidiary of Transform Aid International). This refresh was the creative outcome of a deep dive into our organisational DNA and a rigorous exploration of who we are, what we believe, and where we place our trust.

We coupled this visual refresh with a change in our organisational voice. We developed frameworks to ensure cohesive messaging across the organisation and shifted to a hope-based messaging approach that included biblical formation in our fundraising communication.

With a new visual identity and organisational voice, we developed a new way to give monthly to the work of Baptist World Aid and launched a new magazine. These key engagement pieces enable

our supporters to be informed and updated on the impact of our work, equipped to grapple with poverty, and connected with others as we act for change. Better World Magazine enables a deeper dive into our work and provides an opportunity to challenge and encourage our supporters, giving them opportunities as we work together for a better world for all.

As a result of these new approaches, our fundraising remained strong in FY2022 with a particularly high revenue of \$2.17M raised from special appeals for disasters, including Afghanistan, Tonga and Ukraine. Our partnerships with churches and major donors in Australia also flourished despite the restrictions on gathering churches in many states.

With a focus on God and his story of restoration, the team worked adaptively and collaboratively through another year of COVID disruption towards our goal of ending poverty.

New key engagement pieces enable our supporters to be informed and updated on the impact of our work, equipped to grapple with poverty, and connected with others as we act for change.





In FY2022, our total program investment was implemented across five program areas.



In FY2022, our total program investment was implemented across these regions.



Together in Recovery

Around the world, nations and vulnerable communities are struggling to emerge from the devastating effects of the pandemic. Million are being pushed back into poverty and are on the brink of losing their livelihoods.

With rising inflation, conflict and climate crises, children and other vulnerable groups are disproportionately affected, and household income and access to services have been reduced. Our neighbours in the Indo-Pacific are particularly exposed to the health and economic impacts.

And yet, communities have demonstrated incredible determination to bounce back. In FY2022, it was a privilege for Transform Aid International to partner with 37 local Christian organisations in 24 countries around the world, benefiting a total of 883,907 people. Joining our Partners on this journey towards recovery inspired great hope.

Highlights included:

- Expanding our impact in response to disasters and conflict, amounting to an expenditure of \$1.87M benefiting over 418,432 people. This included forging new partnerships in Ukraine and Tonga, while strengthening long-term partnerships in Solomon Islands, Lebanon, and PNG to provide urgent COVID relief, and joining the Emergency Action Alliance to enhance our collaboration with 15 Australian NGOs during emergencies.
- Growing our relationships with Baptist Conventions working with local churches to mobilise communities, especially within Asia Pacific. Through our partnership with Asia Pacific Baptist Aid

- and Baptist World Alliance, we reached communities in India, Sri Lanka, Myanmar, Haiti, DRC and more with medical supplies, food relief, emergency income, and temporary shelter.
- Working with long-term Christian Partners to sharpen their focus on social inclusion and gender equality within new projects. In FY2022, we collaborated with Partners on 22 project evaluations and 17 new project designs, a record in recent years!
- Evolving our approaches to climate-sensitive and inclusive market-based development in Bangladesh (with two new projects under way). We look forward to learning from such innovative approaches to achieving economic dignity in the future, especially for women and the most vulnerable.
- Strengthening our focus on youth empowerment within our Child and Youth Clubs especially because the pandemic has impacted young people the most.
- The completion of our 10-year Child Centered Community Development program, which directed more than \$30M of funding to at least 136,453 children and their families in eight countries. We are extremely proud of this program, which, according to its final evaluation, represented a radical reorientation of Transform Aid International's sponsorship programming.

From outdated development paradigms, it became a leading, best-practice example of catalysing genuine empowerment, agency and advocacy—especially of children, women, and marginalised peoples.

- Successful programming of \$4.27M, in partnership with the Department of Foreign Affairs and Trade as part of the Australian NGO Cooperation Program (ANCP). In FY2022, our ANCP program worked in six countries, across 14 projects. We are deeply appreciative of their generous support.
- Participating in hybrid learning events with our network of Partners on topics like financial sustainability, safeguarding, Gender Equality, Disability and Social Inclusion (GEDSI), child and youth participation, and measuring impact. In FY2023, we look forward to visiting our Partners after several years of remote collaboration.

In January 2022, it was my honour to take on the role of Director of International Programs following the tenure of Daniel Skehan.
I am grateful for Daniel's years of service to Transform Aid International and the solid foundations he invested in, which in his words, were, 'great people, doing great work, on a foundation of great faith'. I would also like to thank the Programs team and our International Partners for their warm welcome and support during this transition.

As I reflect on the year, I am reminded of the importance of partnership. Whether responding to the ongoing challenges of COVID-19, standing with Christian Partners and vulnerable communities affected by disaster, or conflict in Ukraine. Afghanistan. Sri Lanka and Tonga, or equipping Baptist churches throughout Asia and the Pacific to pursue their own development goals, these efforts demonstrate the reality that together we are stronger. We have experienced 'koinōnia'. i.e.. togetherness in the fellowship of believers (Acts 2:42-47).

Disaster Management and Covid-19 Response

In FY2022, Transform Aid International supported our Christian Partners' COVID response in India, PNG, and Rohingya camps in Bangladesh—reaching 332,687 people. We invested in disaster response projects in Ukraine, Afghanistan, Sri Lanka, Philippines and Tonga, among others. The Disaster Management program reached 85,745 people (other than COVID).

Children, Youth and Communities for Change

In Uganda, Malawi, Cambodia, Nepal and Bangladesh, Transform Aid International is working in partnership with local agencies to facilitate Children, Youth and Communities for Change. These projects receive support from the Australian Government through the Australian NGO Cooperation Program (ANCP). In these programs, children and youth are supported so they can learn more effectively at school as well as learn about leadership, child rights, nutrition, hygiene and more. Children lead and co-design these initiatives, as well as support families and communities as they take part in learning how to create lasting change.

He's only 15 years old, but Pathan* is busy making a better world.

Pathan lives in Bangladesh with his father and grandparents. As a Child Partner in his local Children, Youth and Communities for Change project, Pathan knows that he is capable and trusted to make changes in and for his community. Empowering children to lead and helping them to grow their capacity is a key aspect of the program.

Pathan's leadership has shown up in a variety of ways. He has resolved practical issues, such as gathering a group to repair a broken and unsafe village road. And he has challenged systemic abuses facing children, such as corporal punishment being used in the classroom, and girls experiencing sexual harassment on the way to and from school. Our Partner, Baptist Aid Bangladesh, supported Pathan and his friends so that they could speak up and arrange safe travel for girls. The use of the cane is now also prohibited.

Pathan, like other children participating in the Children, Youth and Communities for Change program, knows that children have rights and that his voice matters. Pathan stopped his friend's family from giving her away in child marriage. She came to him for help and was going to call the helpline they'd heard about in Child Club. Pathan suggested talking to her parents first and went with her to do so. The marriage was stopped, and the family was spared the dishonour of being reported.

When young leaders like Pathan are empowered, big things happen.

Flourishing Farms In Nepal

With support from the Australian Government through the Australian NGO Cooperation Program (ANCP), Transform Aid International's Partner, United Mission to Nepal, works to equip farmers with better seed stock, train them in eco-pesticides and innovative farming techniques, and help them market their produce.

Sani and her husband, Deepson,* are vegetable farmers in Kapilvastu, Nepal. They tended their farm carefully, but it wasn't enough.

The soil is good, rich and fertile, but the area is subject to extreme heat and monsoons which make for difficult farming conditions. And with poor quality seeds, outdated methods and few agricultural tools, their farm yielded very little income. Too little to feed themselves and their three children. Deepson moved to India for work to ensure they had an income.

'We had a difficult life' said Sani. 'It was difficult to afford food, clothes and education expenses for the children. In everything I faced financial problems.'

Thanks to agricultural projects run by our Christian Partner, Sani and Deepson acquired new skills and equipment that helped their farm to thrive. In their first season with the project, they produced enough vegetables to feed their family and sell at markets. This meant that they could buy warm clothes for the children, pay school fees, and

buy the food they don't grow on their own farm.

With new confidence, the couple expanded their farm and, with the assistance of United Mission to Nepal, discovered new and more profitable markets across the border in India. This resulted in the couple tripling their produce in their second season.

With the farm now in a strong position, Sani and Deepson are able to stay together in Kapilvastu, and Sani no longer wonders if she will have enough to feed her children.

Helping to Multiply the Harvest

Unstable weather in Kenya has meant that many farmers struggle to feed their families, let alone build a secure livelihood. Transform Aid International's Partner, Anglican Development Services Eastern, is making a difference through the Integrated Livelihood Improvement Project with support from the Australian Government through the Australian NGO Cooperation Program (ANCP). Anglican Development Services Eastern provides training and resources through community groups where members are provided with support for their individual needs and participate in collaborative practices for the benefit of the whole community.

There was a time when Judy* and her husband Musyoka* weren't sure they'd have enough food to last more than a few months. Their 1.5-acres of land in the Kitui county of Kenya produced so little that Judy relied on the kindness of neighbours and casual work.

'This was a harsh time for our family,' she said. 'We had to skip meals to make sure we survived the dry spells, and my children's immune system went down because they lacked vegetables and fruits.'

The children often became ill and missed a lot of school, especially when Judy had to prioritise spending money on medications instead of school fees.

Together with other young mothers, Judy joined the Anglican Development Services Eastern program and received training in governance, tree planting, child protection, soil fertility management, village savings and even animal production. She learnt new techniques including

the importance of diversifying her income sources. She also began raising chickens and goats.

Over time, and with hard work, these innovations saw Judy's crop yields grow by 700 per cent! With her more robust income, she can ensure her family's nutrition, pay debts and school fees, and has purchased and fitted solar panels on her home.

Judy continues to serve her community club through helping others develop sustainable farming practices.

Global Baptist Impact

In FY2022, Transform Aid International continued investing in the global Baptist response to COVID-19. In total, Transform Aid International supported 10 Baptist-associated partners to implement disaster response, community development or child-focused programming.

As an active member of the Baptist Forum for Aid and Development, Transform Aid International supported and equipped Baptist Conventions around the world to respond to humanitarian needs and participate in community-led disaster risk reduction in countries including Ukraine, Haiti, Democratic Republic of the Congo (DRC), Sierra Leone, and countries bordering Myanmar.

Transform Aid International continues to support the vision and rollout of the Asia Pacific Holistic Transformation Strategy—a critical part of Asia Pacific Baptist Federation's long term mission. This strategy involves equipping and mobilising Baptist Conventions and local churches within their network to become agents of change. FY2022 highlights included piloting a learning management system for pastors and forging new community development partnerships in Nepal and Bangladesh.



Monitoring and Evaluation

Transform Aid International is committed to improving development effectiveness. This involves regular reflection on practice, actively learning through research, project monitoring, project evaluations, and listening to Christian Partners.

In FY2022, Transform Aid International commissioned a meta review of the impact of 10 years of child and youth programming. We continued to support our Partners to conduct their own research and learning, and apply it towards evidence-based development programs. Research conducted by five of our Partners on adapting child and youth programs during COVID-19 was presented at a global conference.

FINANCIALS FY2022

FY2022 Financial Summary



Natasha Thompson CHIEF FINANCIAL OFFICER

Financial Year 2022 continued to tell a story of steadfast support from our community, despite economic uncertainty across Australia and in the nations where our Partners work. Our total income exceeded \$18.9M which is on par with the prior year result once the large gift in kind received in 2020 is excluded. If the prior vear's Government Grants for COVID-19 stimulus payments are excluded, our revenue exceeded the previous year by 5.1%. Transform Aid International also achieved a small surplus for the vear of \$94.3K which was in line with expectations.

Income

Donation revenue increased in the year, which reflects the commitment of our generous supporters. Major donors generously contributed \$1.15M, which was a significant increase from the previous year. Grant income from the Department of Foreign Affairs and Trade (DFAT) increased by 6.6 per cent to \$4.3M. Transform Aid International is a valued partner of the Australian Government, receiving flexible funding under the Australian NGO Cooperation Program (ANCP).

We're extremely pleased with the results of our special appeals with supporters responding to significant disasters and conflicts, including in Ukraine and Afghanistan, and the Tongan Tsunami. Total funds raised for disaster and humanitarian appeals were \$2.17M compared to \$1.48M in the prior year.

Expenditure

Our total expenditure of \$19.1M was on par with prior year total expenditure of \$19.2M. Our impact expenditure—which includes the areas of international programs, advocacy, and education—was \$12.7M. excluding aifts in kind. a significant increase over the previous year of \$11.4M. The distribution of special appeal funding raised in FY2021 from COVID appeals and FY2022 from disaster appeals (outlined above) assisted to increase our impact expenditure. This meant we were able to see more funds in the hands of our Partners going directly to our impact areas.

Our hedging policy requires us to hedge a portion of funds against the USD. Our strategy was successful and protected the value of our AUD income. The total combined fundraising and administration costs for the year decreased for the year, to 34 per cent.

Financial Position

Our balance sheet continues to be robust with no large, long-term liabilities or borrowings and total net assets of \$11.6M. Overall reserves are healthy and include \$2.1M designated for humanitarian crisis projects, \$0.2M funding for child projects, \$0.5M funding for work in Africa, \$1.0M for strategic initiatives in the Asia-Pacific region, and over \$4.1M for general and multi-year community development projects.

We remain grateful for the wonderfully generous Australian Baptist churches, our amazing supporters, and the Australian Government.

Special Projects

Our team has worked hard preparing for the Department of Foreign Affairs and Trade accreditation review, which concludes later in 2022. We welcome the opportunity to demonstrate the high quality of Transform Aid International's work.

As we see a world increasingly impacted by conflict and disruption, we are more cognisant than ever that we are entrusted with significant financial provision from our faithful God. We remain grateful for the generosity of Australian Baptist churches as well as from our faithful supporters and the

Australian Government. Their continued partnership means we can work together towards a world where all people can experience fullness of life as God intends.





Legal and Regulatory

Transform Aid International Ltd commenced operations under the new company structure from 23 July 2013 (ABN 63 430 709718). Baptist World Aid Australia Ltd (ABN 86 164 099 736), as a wholly owned subsidiary, was established to continue and expand its Australian operations. Transform Aid International Ltd is the aid and development agency for Australian Baptist Ministries and operates as a Company Limited by Guarantee with its own Board.

Transform Aid International Ltd is a registered charity with the Australian Charities and Notfor-profits Commission (ACNC). It operates nationally and holds fundraising licences in all Australian states where required to do so. Transform Aid International Ltd is an approved Deductible Gift Recipient (DGR).

Transform Aid International Ltd engages the services of the following organisations:

Banker - National Australia Bank; Auditor - Saward Dawson; Lawyer - Corney and Lind Lawyers.

Transform Aid International Ltd has full accreditation from the Department of Foreign Affairs and Trade (DFAT) which enables the receipt of government funds for its programs. Transform Aid International Ltd acknowledges not only the funds, but also the care and support of key government

agencies, and their staff, in carrying out work together.

Transform Aid International Ltd is a member of the Australian Council for International Development (ACFID), demonstrating its annual compliance with their Code of Conduct. This is a voluntary, self-regulatory Code of good practice. As a signatory, Transform Aid International Ltd is committed to adhering to the Code of Conduct, and conducting its work with transparency, accountability and integrity.

Baptist World Aid Australia Ltd, as a wholly owned subsidiary of Transform Aid International Ltd, also adheres to the requirements of ACFID's Code of Conduct.
